BACKGROUND

There is a continuous need to analyze the midwifery education programme. New and rapidly changing challenges in the health care sector demand that the education of midwives is continuously re-evaluated. As new member states join EU it is important to understand the various levels and standards of midwifery education in all the countries. In addition, EU policies for free movement of midwives within the EU drive the need to provide an opportunity for discussion, networking and collaboration between different organizations and countries. To bring together the leading midwifery educators and practitioners to provide a forum for challenge, exchange and dissemination of ideas and initiatives in contemporary midwifery education across EU member states.

OBJECTIVES:

- ◆ To enable midwife practitioners and educators to share ideas and expertise to support midwifery education in Europe;
- ◆ To explore how education can promote the profession and develop competent and confident midwives to meet the needs of women and babies;
- ◆ To place midwifery in the driving seat to deliver EU health policies by engaging with politicians and increase their awareness of autonomous midwifery at clinical, educational and research level;
- ◆ To become familiar with the challenges faced across Europe to meet the educational and regulatory needs of midwives;
- ◆ To explore the challenges of multicultural society and how midwives can support women;
- ◆ To highlight the value of midwifery care to women, babies and families to improve the health and well-being of wider society.
