Dear Ms. Cavaco,

I am writing on behalf of the Board of Directors of the International Council of Nurses (ICN) to express our support for the Ordem dos Enfermeiros during the outbreak of the COVID-19 virus.

We understand that cases are continuing to increase in Portugal as in many countries across the world. We applaud your work to keep nurses and patients informed via your website. Ensuring that people have access to accurate and timely information is essential in the battle against this virus. We also support the open letter you wrote, in collaboration with the Order of Doctors and the Order of Pharmacists, to Prime Minister Antonio Costa, calling on the government to provide basic measures to contain the pandemic and to provide more personal protective equipment (PPE) and testing.

ICN is very concerned about the health and safety of nurses, as well as that of the population at large. We are working closely with the World Health Organization to support the global effort to defeat this virus, calling on governments to ensure that health workers are tested for the virus, have access to a sufficient supply of PPE, provided with proper training and given psychological support to help them through this incredibly difficult time.

You may have seen our recently released [statement](#) on the grave situation in Italy where nurses and other healthcare workers lack the sufficient protective equipment to keep them safe. This is a stark warning to other countries around the world to ensure their health workforce is protected – both physically and psychologically. Like you, ICN's CEO, Howard Catton, has been very active in the media promoting this message that countries must prioritise and protect nurses and health workers right now.

This is a global crisis which requires a global response. Our aim is to share lessons learned by national nursing associations across the world. We held a webinar on 27 March which brought together representatives from ICN, WHO and leaders of NNAs in the hardest hit countries. ICN, as the global voice of nursing, will continue to enable this sharing of information and experience so we may all learn from them. We are also issuing [weekly updates](#) on the situation with links to the latest guidance and information which you may find useful to share with your members.
